Safe Return to In-Person Instruction and Continuity of Services Plan

Introduction:

Nazareth ISD will be applying for CRRSA, ESSER II and ARP, ESSER III funding. The purpose of ESSER II is to prevent, prepare for or respond to the COVID-19 pandemic. The purpose of ESSER III is to help safely reopen and sustain the safe operation of schools and address the impact of the coronavirus pandemic on students. The plan that follows is a draft intended to outline Nazareth ISDs planned safety measures for the 2022-2023 school year while continuing to provide an excellent educational experience.

Maintaining Health and Safety:

To reduce the risk of transmission Nazareth ISD plans the following mitigation strategies for the 2022-2023 school year includes, but is not limited to, the following:

- Touchless water fountains with bottle fillers
- Optional wearing of masks
- The use of assigned seating when appropriate
- Proper handwashing encouraged
- Hand sanitizer available
- Targeted cleaning as appropriate
- Improving ventilation
- Positive cases will be reported to the local health department
- A student who presents symptoms at school will be isolated until a parent can be contacted to pick up the student

January 11, 2023

- Contact tracing will be conducted as applicable and parents will be made aware of positive cases in their child's class(es)
- Staff and students who test positive and/or are actively sick with COVID-19 will be excluded from campus to quarantine for 10 days
- Area/local vaccination sites and/or providers available on our website
- Appropriate accommodations for students with disabilities as identified in the student's Individualized Education Program
- Using diagnostic rapid testing when appropriate

Ensuring Continuity of Services:

Nazareth ISD will continue to take appropriate actions to ensure continuity of services to students. These actions will focus on addressing students' academic, social, emotional, and mental health needs as well as the social, emotional and mental health needs of the staff. Proposed plans to provide a continuity of services includes, but is not limited to, the following:

- Technology updates
- Instructional materials/resources, activities, and outreach to meet the needs of students
- Social and emotional/counseling, wellness supports to students and professional development (training) to staff
- Professional Development for Educators
- Summer School
- Tutorials to accelerate learning
- Professional Application subscription to recruit/attract quality applicants for openings

Opportunity for Public Comment:

During the development of the plan, student data informed input from staff throughout the district. Needs were prioritized based on wellness and instructional continuity. Staff, student, parent, and community surveys were opened for input from July 5, 2021, through July 13, 2021. The survey input and a draft of this plan was presented for public comment through the Board of Trustees Meeting held on Wednesday, July 14, 2021, and priorities were set from that input. The plan was then finalized and presented to the Nazareth SBDM on Tuesday, July 20, 2021. The Plan was posted prior to application submission. Periodic Review and Revision of the Plan:

During the period in which ESSER III funds are available, Nazareth ISD will review and revise the plan at least every six months. These revisions will rely on staff, student, parent and community feedback, as well as updated guidance from the Texas Education Agency.
