



CAPITAL IMPROVEMENT BOND FOR INSTRUCTIONAL FACILITIES

2024 BOND ELECTION

Nazareth Independent School District has called for a **\$2.15 million** Bond Election to be held on Tuesday, November 5, 2024. Early Voting is October 21–November 1 at the Castro County Court House.

Proposal

To fund instructional facilities construction, renovations, repairs, and upgrades.

Summary

If passed, the bond would fund an update to the district's instructional facilities, facility repairs and improvements, safety and security measures, and equipment for classrooms.

Proposition A: \$2.15 Million

Instructional facility construction, capital projects, facilities repairs, and equipment:

- Construction of a new science lab, ADA compliant restrooms with a storm-ready hallway
- Renovation/conversion of the old science lab to two classrooms
- Facility repairs and capital improvements
- Safety and security measures
- Classroom equipment

When was the last bond NISD bond election?

2003

Will my tax rate increase from the previous year if the bond propositions pass?

We do not anticipate a tax rate increase. The future tax rate will depend on future property values in the District.

What projects were financed with the previous bond?

Cafeteria, stage, and classroom renovations, a new roof on the main building, an ag shop addition, exterior doors, carpeting, tile, painting, HVAC system replacement, and gas line replacement.

OTHER CAPITAL PROJECTS PLANNED

The district is planning other construction projects that would be paid for from fund balance:

- Construction of a new field house for boys' physical education. The old field house (circa 1985) would be kept for an extra dressing room & storage.
- Remove the barracks dressing room (circa 1970s) on the back of the Quonset Gym and build new dressing rooms for girls' physical education. The Quonset Gym (w/ dressing rooms) is used daily and for the annual basketball tournament.

Tax Rate Information

Projected Impact of Bond on Tax Rate (I&S AND M&O):

- The current I&S rate of \$0.13 will not increase for fiscal year 2025 and is not anticipated to increase in future years.

Current Tax Rate:

- Total Tax Rate \$0.97250 (M&O = \$0.84250, I&S = \$0.13)
