

**ORDER OF THE BOARD OF TRUSTEES
OF NAZARETH INDEPENDENT SCHOOL DISTRICT
CANVASSING THE RETURNS AND DECLARING THE RESULTS OF THE VOTER-
APPROVAL TAX RATE ELECTION HELD ON NOVEMBER 7, 2023, AND
CONTAINING PROVISIONS NECESSARY AND INCIDENTAL THERETO**

WHEREAS, an election duly authorized by the Board of Trustees of Nazareth Independent School District (the “District”) was held in the District on November 7, 2023, for the purpose of submitting a certain proposition to approve an ad valorem tax rate to the resident qualified electors (the “Election”); and

WHEREAS, this Board has investigated all matters pertaining to said Election; and

WHEREAS, it is hereby found and determined that notice of the Election was duly given in the form, manner and time required by law, that proper election officers were duly appointed before the Election, and said Election was in all respects legally held and conducted in accordance with applicable laws of the United States of America and of the State of Texas and the proceedings calling and governing the holding of such Election.

THEREFORE, BE IT ORDERED BY THE BOARD OF TRUSTEES OF NAZARETH INDEPENDENT SCHOOL DISTRICT:

SECTION 1: That all of the recitals contained in the preamble of this order are officially found and determined to be true and correct and are adopted as findings of fact by this Board of Trustees.

SECTION 2: That it is officially found and determined that the returns of said Election have been duly and legally made by the election officers who held the Election and were submitted to this Board of Trustees, and this Board of Trustees has duly canvassed said returns, all in accordance with the law and the proceeding calling said Election.

SECTION 3: That it is officially found and determined that the following votes were cast at said Election on the submitted proposition by the resident qualified electors of the District who voted at said Election:



SECTION 5: That it is hereby officially found that the meeting at which this Order has been considered and adopted is open to the public as required by law, and that written notice of the time, place and subject matter of said meeting, and the proposed adoption of this Order was given as required by Texas Government Code Chapter 551.001, *et seq.*
